Caney Valley Public Schools would like to utilize up to two instructional days of remote (Virtual) instruction due to inclement weather. The Caney Valley School District encompasses over 220 square miles of territory. Less than 10 square miles of this area is located within town boundaries. Over 210 square miles of our district is in rural areas with many gravel roads. The landscape varies between rolling hills, flatland, and the Caney River wetlands. During winter time, many of these roads are not suitable for travel as the county focuses on the more traveled thoroughfares. In addition, periodically, the Caney River floods its banks leaving much of the southern and eastern part of our district inaccessible. By having the option to utilize remote instruction we can still maintain the continuity of our instruction without a negative effect on our students.

Our School Board is being asked to approve this plan at the November 3rd, 2025 regular board meeting. This plan will work in tandem with our calendar which provides for 3 days of inclement weather built into the schedule. By utilizing the two strategies together, we are better able to maintain the flow of instruction to our students, but not put a strain on families who may have technology issues during the inclement weather. Dr. Steven Cantrell and the building principals will be responsible for the oversight of the program and be tasked with maintaining the integrity of the remote instruction. This plan will be reviewed annually by the CVS Virtual Instruction Committee and the Board of Education.

Remote Instruction (Virtual Delivery) – All classes will be taken at home in the form of virtual instruction and learning. CVS may use Remote Learning Days as determined necessary by school officials. CVS staff will implement and distribute lessons using the Google Classroom and other digital learning platforms as needed. Students will follow their normal schedule and connect with their assigned teacher of record each class period. Instruction will follow the Oklahoma Academic Standards, but may not follow the exact sequence of instruction taught during in-person instruction. Attendance will be calculated based on the students' completion of 90% of the assigned work prior to the due date and correspondence with the teacher of record.

Instruction will be provided through a hybrid system of recorded lessons, and/or live interactions between the teacher and students. Staff will also prepare hard copy lessons of the

virtual material to pass out to students. Each virtual hard copy packet will follow with the online instruction, but will include all materials needed for the student to still be successful in completing the coursework. All staff members will be available during regular school hours for their classes. The teacher will take role at the beginning of each session. They will provide the instruction through the medium chosen and remain available throughout the class period to provide assistance as needed. Students will be given 1 day upon returning to school to complete the assignments as presented. Students needing extra assistance may attend after school tutoring at the middle and high school. Elementary students will be able to work through any issues during their regularly scheduled Math and/or Reading Intervention times.

Parents will be notified through SCHOOLSTATUS and social media of the need to go remote for the day. After each day of remote instruction the district will evaluate the attendance rate compared to normal in-person instruction as well as the quality of work presented by the students. This plan will be reviewed by the Virtual Instruction Committee, the District Leadership Team, and the CV Board of Education annually to determine its effectiveness.



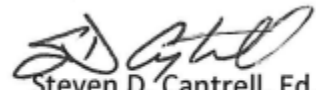
